Education, Training and Experience

I'm Chloe, I use she/her pronouns and am a white, genderqueer, queer art therapist, endemic to this mossy part of the world. I've lived in Southern Oregon, Washington, California, and Colorado. Portland continues to be what home feels like. Art has played a huge role in my survival and my belief in it stems from my own intimate relationship with it.

I hold a B.A. in Visual Art and Psychology from The Evergreen State College, a master's degree, M.A. in Transpersonal Art Therapy and from Naropa University's CACREP-equivalent program where I focused on transpersonal art therapy, humanistic and somatic counseling methods, and group dynamics. I am a Licensed Professional Counselor in the state of Oregon. I am also a Qualified Mental Health Professional (20-QMHP-R-0902) and have my Registered Art Therapist Provisional Certification in the state of Oregon. I work with individuals, relationships, and groups on a wide array of areas including anxiety, depression, life changes and adjustments, PTSD and other trauma healing, minority stress, sexuality and gender affirmative care, sex and relationship concerns.

As a Licensee of the Oregon Board of Licensed Professional Counselors and Therapists, I abide by its Code of Ethics. To maintain my license, I am required to participate in continuing education, taking classes dealing with subjects relevant to this profession.

Philosophy and Approach

I utilize the healing power of present, experiential, creative expression in my transpersonal art therapy practice. I believe in the ability of art (whatever medium) to articulate better than language, and radically hold and express each individual's relative story. While utilizing the art process, I bring a somatic and relational approach all while holding each person's context within a social justice informed container. I bring a person-centered, trauma-informed, queer-feminist lens to all that I do with clients. I also provide gender affirming care based on the World Professional Association for Transgender Health (WPATH) standards of care.

Artwork in Art Therapy: I will hold confidential all artwork you produce in our art therapy sessions and store all copies in a HIPAA compliant confidential folder. I will share your art only with my direct art therapy supervisor for the purpose of receiving quality consultation on your case.



I specialize in working with individuals, couples and groups within queer and trans population through struggles with depression, anxiety, trauma, gender dysphoria, narcissistic abuse, identity, religious recovery, coming out, life transitions, low self-esteem, relationship issues, existentialism, minority stress, and apocalyptic anxiety. I work with adults 18+.

Fees Information and Cancellation Policy

Intake Session (53 minutes) \$200 Individual Session (53 minutes): \$180

A limited amount of sliding scale spots are available and agreed upon before our first session. Credit cards, cash, Venmo and personal checks made payable to "Healing Tides Counseling" are accepted.

When we schedule an appointment, I set aside that time exclusively for you. I would like a 24-hour advance notice if you must cancel or reschedule any appointment. It is my policy to charge a fee of \$100 for any missed appointments or one that is canceled with less than 24-hour notice.

Healing Tides Counseling, LLC requires each client to add a credit card on file to charge copays, as well as late cancellations and no show fees.

Insurance Reimbursement

If you have a health insurance policy, it will often offer some coverage for mental health treatment. We will provide you with whatever assistance we can in helping you receive the benefits to which you are entitled; however, you, and not your insurance company, are responsible for full payment of treatment fees.

Please note: submitting claims to your insurance company requires a mental health diagnosis and carries a certain amount of risk to confidentiality, privacy, and to future capability to obtain health or life insurance. Client Rights

As a client of a Licensed therapist, you have the following rights:

- 1. To expect that a licensee has met the minimal qualifications of training and experience required by state law.
- 2. To examine public records maintained by the Board and to have the Board confirm credentials of a licensee.
- 3. To obtain a copy of the Code of Ethics.
- 4. To report complaints to the Board.
- 5. To be informed of the cost of professional services before receiving the services.
- 6. To be assured of privacy and confidentiality while receiving services as defined by rule and law, including the following exceptions:
 - a. Reporting suspected child abuse
 - b. Reporting imminent danger to client or others
 - c. Reporting information required in court proceedings or by client's insurance company, or other relevant agencies
 - d. Providing information concerning licensee case consultation or supervision; and
 - e. Defending claims brought by client against licensee.
- 7. To be free from being the object of discrimination based on race, religion, gender, or other un- lawful category while receiving services.

I believe that adding clients as friends or contacts on these sites can compromise your confidentiality and our respective privacy. It may also blur the boundaries of our therapeutic relationship. If you have questions about this, please bring them up when we meet and we can talk more about it.
